- hold an Australian ABN
- (if applicable) hold a State Licence; and
- confirm we distil at least 51% of our alcohol from our stills.

I understand that if I own a Still and I am distilling my product, even if it is not available for sale yet, then I am required to join as a Full Member. I understand that as a Full Member, irrespective of my membership category (Tier 1, 2 or 3), this entitles me to one (1) vote at the Annual General Meeting.

All applications for membership are subject to approval by the Executive Committee, as stated in the Rules of Association, Section 6.6.

A person or body corporate that wishes to become a member must:

- a) Apply to the Committee in writing Signed by the person, if a natural person, or by the chief executive officer, if a body corporate
- b) Be proposed by two existing Australian Distiller Association members; and
- c) Set out which class of membership they wish to apply for.
